- 9. BID Executive Director John Gilbert
  - a. John Gilbert said there will be a Responsible Beverage Service training meeting for owners, general managers, and managers of bars in Huntington Beach. As of today, there were about 50 people planning to attend. A presentation will be given by former Shark Club owner Gregg Hanour. This training is being put on by Waymakers, MADD along with The Huntington Beach Police Department and the BID. John said they are anticipating Police Chief Handy and Assistant Chief Rodriguez will be in attendance. Mike Ali stated that he thinks this will help create a positive image for Downtown and he wanted to acknowledge what a great job John did on organizing this. John said this type of meeting had never been done in Huntington Beach before.
    - b. John Gilbert informed us that the City Attorney is reviewing the new BID Employee handbook. An alternative motion pending verification from the City Attorney to approve the handbook was made by Kate Leigh and Seconded by Mike Williams. Vote passed 7-0.

#### 10. Events Coordinator - Darci Henderson

- a. Darci Henderson reported on Miracle on Main St. everything went well. Miracle came in under budget this year. We are looking into making this a bigger event in the upcoming years. Music has been added to the Christmas Tree. John mentioned that all of the family friendly events that we have had this year have been awesome. Kate Leigh let everyone know that Santa Paws on 5<sup>th</sup> and PCH was a hit. There were 4 dogs adopted at the event. Pictures with Santa were taken with the adults, dogs and kids.
- b. Surf City Nights is going well. We have a few new vendors starting this month as well as 3 new farms starting in January. Kelly was asking what the revenue of SCN is on a weekly basis and how much we lose when we have to close for the night. Kelly also asked how much a space is and Darci informed him that it is based on what type of vendor you are.

John stated because of the two closures on December 24 and December 31 we may need to pull from the reserves. Darci stated that parking and taxes are a pass through with the city. The city does not get any of the rent collected for SCN. We do pay the city for half of the bollard costs and they pay the other half.
