5. One-Year Review of Surf City Artisan Fair

Jaime Strong presented a review of the Surf City Artisan Fair. In December, HB Downtown submitted an RFP to operate Pier Plaza and hired Jodi McKay from Event Fusion as the event operator. HB Downtown received approval from the council to operate the Pier Plaza Artisan Fair in March 2022. Jodi has a lot of

talent in working with the vendors and creating community at the event through the Four Corners. The original budget was very conservative; it has evolved over months. The first year did a little over 84k in profit, with 10 dates canceled due to the weather. There is room to grow the event and add vendors.

Jodi McKay provided an overview of vendor acquisition and onboarding new vendors. Vendors must be at least 75% handmade or with an original design, seasonally updated product, have a social media presence, and all their correct compliance documents. The four corners were intended to show the grassroots history of our city, connectivity, and create a fresh weekly popup. This is done through thoughtful partnerships for each corner - nonprofit corner, learning corner for kids, creative corner, gathering corner.

Brett Barnes recommended forming a Surf City Artisan Fair Taskforce.
