5. Public Space Dining/Temporary Main Street Closure

- b. Information: City Council item 20-1642 passed on May 18, 2020 directed staff to develop a program to temporarily allow conversion of adjacent public and private areas to be utilized for outdoor dining.
- c. BID conducted a survey with stakeholders asking for their input and recommendations for the closing of Downtown Main Street. Survey results indicated over 84% of respondents recommended some temporary closure of Main Street due to Covid-19 to improve "Social Distancing"

Recommendation: Work with the City to adopt an approved "Dining Plan" to allow additional Public and Private areas to be used. Discuss and implement a Temporary Main Street Closure Program to facilitate improved "Social Distancing"

a. Information: Currently on a month to month contract with Allied Universal and submitted an RFP to (4) companies to bid on annual contract. Attachment summarizes the "billable rates" for the submitted companies
