3. Treasurer Report-Financials

Treasurer Mike Williams will report on the current financial information provided by the CPA. **Recommended Action:** Record and file February accountants' compilation report for HBDBID.

4. Ambassadors Security Program – March – June 2021

Tony Alvarez, President of 12 "0" 27 Protective Services, will provide a brief overview of the ambassadors security program and how his team works with the HBPD. The ambassadors program is a weekly weekend enhancement of Downtown security. There are three agents scheduled each six-hour shift at a rate of \$30.37 per agent/ per hour. has been on hiatus since 4th except for holiday weekends (MLK and President's Day). VHB has budgeted to fund half of the program through the end of their fiscal year, June 30, 2021. Projected monthly cost to the BID is approx. \$3,500 depending on the number of weekends and any extended shifts.

Recommended Action: Discuss and approve funding for the Downtown ambassadors security program through June 30, 2021 to coincide with approved VHB funding. Cost not to exceed \$15,000 (in the event of extended shifts for holiday weekends).

5. Information: EV Bike Program

The City and HBPD are exploring the enforcement of existing EV codes on the beach path. BID members will be affected by enhanced enforcement.

Recommended Action: Discuss current scenario and develop a business-friendly approach that works with City and PD objectives. Direct BID staff to draft a letter communicating BID position to the City and PD and desire to participate in any possible Task Force to study this situation.

6. Information: Discussion of 3rd Block Closure Through Labor Day

There has been interest expressed by some 3rd block businesses in revisiting the earlier request to close the 3rd block of Main St. to traffic through Labor Day to better synchronize the 2nd and 3rd blocks. The BID BOD voted to make this recommendation in Oct. and has not changed its position with a vote. The 3rd block continues to be divided on this topic and the lessening of COVID restrictions appears likely.

Recommended Action: Direct BID staff to conduct a new survey of 3rd block businesses and the local community to assess current support and sentiment for a closure. Additionally, direct BID staff to request sales tax reports or other available data from the City to analyze activity before, during, and after the previous closure with consideration to the state of COVID restrictions during those periods.
