6. Surf City Nights Rate Increases

The BID staff has determined it appropriate to increase the rate for the crafter category of business in the market based on competitive research.

The Downtown Experience Survey demonstrates strong support for expanded pedestrian and outdoor dining areas in Downtown HB. Reviewed in conjunction with the previous Downtown survey from Oct. 2020, there is consistent support for additional block closures regardless of the level of COVID restrictions.

Recommended Action: Discuss and approve presentation of survey results to City Council and City Staff.

- 2. Do you want 2nd block closed to vehicular traffic? Why/why not? If yes, through Labor Day or permanently?
- 3. Do you want 3rd block closed to vehicular traffic? Why/why not? If yes, through Labor Day or permanently?

Please provide details, sales reports or other empirical data to support your position. Recommended Action: Discuss and approve additional survey to be distributed by end of day Friday, May 14th.
