11. Malco Rate Increase

Action: Discuss and approve current monthly cleaning increase from \$16,500.00 to \$17,702.00 starting in October 2023.

- The increase is about \$1200 a month. HB Downtown can find a new company in budget or money can be reallocated in the budget to cover the Malco rate increase.
- The BOD asked staff to request a locked rate (2-5 years) with Malco and vote pending that conversation.
