7. Office Staff

Information: Brett Barnes gave an update on BID Office Staff. After two recent resignations, there are currently 3 open positions – Executive Director, Coordinator, and Market Manager. There are also two open Board of Director positions after two recent resignations. The BID Bylaws state in the event of a resignation, the President is to appoint new board members to fulfill the remainder of the term. This will be completed by Monday, with the help of BID Past President, Dave Shenkman. Item #8 on the agenda will address the open Executive Director position. In the meantime, both Jaime Strong and Maddie Gates have offered to help during the transition.

8. Interim Executive Director

Action: President Brett Barnes introduced options for an Interim Executive Director. The former Interim Executive Director from 2019-2020, John Gilbert, is available for up to 6 months during the transition time. Gilbert is a former Hilton Hotel general manager with 49 years of executive hospitality experience. During his previous time with the BID, he created processes that are still in use today.

A motion was made by Brett Barnes, second Suzie Smith, to approve John Gilbert as the Interim Executive Director, subject to the BOD approval of his contract, which is currently under review by the City of HB.
